## PRIVACY DISCLOSURE STATEMENT FOR MEMBERSHIP APPLICATION FORM (‘STATEMENT’)

(In this Privacy Disclosure Statement, ‘MBC’ means The Mt Barker Co-operative Limited)  
From 21 December 2001, MBC is required to comply with the National Privacy Principles (‘NPPs’) contained in the *Privacy Act 1988*. The NPPs set out minimum standards for the way in which organisations handle individuals’ personal information. This statement is provided in compliance with NPP1.3.

MBC collects and holds personal information about you when you apply to become a member of MBC. The personal information collected is typically your name and contact details, your occupation and your employer’s details.

MBC collects most of the information it requires directly from you on the ‘Application for Membership’ form. MBC may collect additional information from you by telephone, in person, by its representatives or by written correspondence from time to time.

MBC collects information for the purpose of processing your application for membership and servicing you as a member. If you do not provide us with all the information requested, we may not be able to process (and therefore may reject) your application for membership.

MBC may provide your personal information to its agents, contractors or service providers who act on MBC’s behalf or who provide goods or services to MBC (for example delivery drivers). The identity of these agents, contractors and service providers may change from time to time.

We may also use your information to inform you about certain activities, goods and services of MBC or third parties, which we consider might be of interest to you. You may notify us at any time if you do not wish to receive this information by writing to our Privacy Officer at the address shown above.

You may seek access to the personal information held about you by MBC at any time (although some requests may be denied in certain circumstances). We will correct any information that we consider is inaccurate, incomplete or out of date.

Before providing us with any details about another individual, you must ensure that the individual is aware of:

- The proposed disclosure of their information to MBC and the purposes for which the information is collected by MBC; and
- The individual’s ability to request access to the information held about them by MBC under the *Privacy Act 1988* (and to advise MBC if they think the information is inaccurate, incomplete or out-of-date).

Welcome to the Mt Barker Co-operative Loyalty Rewards Card Program.

The Mt Barker Co-operative was formed in 1918 to assist members in the export of their Apple and Pear crops and later to provide packing and cool store facilities.

Today some 90 plus years later the Co-operative has seen many changes progressing from the Cool Storage Facilities to operating a robust Supermarket, Hardware, Rural Merchandise and Fuel Services with annual sales in excess of 18 million dollars.

The Co-operative has been and is still controlled by a Board of 7 Directors who are elected by Members to govern the business. Their role over the years has seen the re-development of the Co-operative into a secure solid performing business. The Board of Directors declares a rebate and dividend to members every year depending on what profit has been achieved.

To become a Member of the Co-operative is quite simple; all that needs to be done is fill in the Application for Membership form and return it to the company's office. Once approval has been given by the Board of Directors and payment has been made for your shares, the recording of your trading begins. The amount that will be returned to any member in the form of cash rebate vouchers and or bonus shares, depends on how much trade is conducted by that member over the trading year. The Co-operative has over 2,500 Members who enjoy the benefits returned to them by way of trading rebates.

Recently the Co-operative announced a new benefit for its members - the Loyalty Rewards Card (Members Card). Members are rewarded for their loyalty by recording the purchases made within the Co-operative's Supa IGA Supermarket. Currently, once \$2500 has been spent a \$20.00 voucher is sent to that member.

The voucher can be redeemed for goods at either the Co-operatives Supa IGA or Mitre 10 store.

This is an added benefit to Members and does not replace yearly rebates and dividends. The Voucher must be signed and presented by the approved Member only when redeeming for goods. Identification may be required.

## Terms and Conditions:

- Approved Members only must present the Members Card to checkout staff during the transaction to enable recording of purchases.
- The use of the Members Card is at the absolute discretion of the Mt Barker Co-operative and can be varied from time to time without notice.
- The Members Card is not transferable and remains the property of the Mt Barker Co-operative.

Enclosed is an application form for you to return should you wish to join in the Loyalty Rewards Card Program (Members Card) and at the same time start to enjoy the other benefits of being a member of the Mt Barker Co-operative.
